

REDRAW YOUR WORLD WITH CHINGAY50

Terms and Conditions

Important Information

"Redraw Your World with Chingay50" (the "**Programme**") is organised by the People's Association (the "**Organiser**") in conjunction with Chingay 2022 (referred to as "**Chingay50**" in these Terms and Conditions). WarnerMedia – Cartoon Network ("CN") is a partner of this programme.

By submitting entries for this Programme, you (also referred to herein as the "Participant") hereby declare that you acknowledge and accept all the terms and conditions set out herein ("Terms and Conditions").

(A) PROGRAMME DETAILS

1. About the Programme

1.1 The Programme is part of the outreach effort of Chingay50 where the community is encouraged to participate in designing their own float using a template produced by CN and downloadable at www.chingay.gov.sg/CNRYWChingay50.

2. Programme Details

Prizes	10 lucky entries will be <u>selected randomly</u> from all eligible entries and each will win one (01) Cartoon Network Redraw Your World Prize Pack.
	Winners will be announced after 25 March 2022 and notified on details of prize distribution.

3. Eligibility Criteria

- 3.1 The Programme is open to all Singapore Citizens, Singapore Permanent Residents, and persons living in Singapore with a valid student or work visa, or long-term visit pass. Participation is free.
- 3.2 Each Participant who is below 18 years old at the time of registering, must obtain his/her parent or legal guardian's (i) consent for the Participant to take part in the Programme and (ii) agreement to these



Terms and Conditions before participating. The Organiser reserve the right to request, at any time, written evidence of such consent obtained.

- 3.3 All employees of the Organiser and their immediate family members, as well as appointed vendors of the Organiser who are involved in the Programme, may participate in the Programme. However, they will not be eligible to win or receive any prizes.
- 3.4 Each entry for the Programme must be an <u>original work.</u> By submitting the entry, you represent and warrant to the Organiser that the entry is an original work. If necessary, the Organiser may require you to provide further documents and/or information for verification. The entry must not have been entered in any previous competitions or any other public display and must not have been previously published in any form or on any other platforms in Singapore or elsewhere.
- 3.5 Entries must not contain any inappropriate content of any kind, including but not limited to content that (i) is obscene, hateful, defamatory, violent or offensive; (ii) promotes discrimination against any group or individual; (iii) contains any religious, political, advocacy or commercial messaging; (iv) contains any viruses, worms, malware, Trojan horses or other harmful software of any kind; or (v) is in the Organiser's view inappropriate.
- 3.6 Participant can submit multiple entries only if each entry contains a <u>different</u> original work.
- 3.7 By making a submission to the Programme, Participants declare and represent to the Organiser that the entry is in compliance with all applicable and relevant laws and regulations (including those relating to intellectual property and personal data protection) and have given their consent and/or permission for the submission as part of the Programme, and for its usage in the Programme.

4. Prize Winners

- 4.1 All prize winners will be notified via Facebook Messenger or Instagram Direct Message ("Notification Platforms") on details of the prize distribution. It is a prize winner's responsibility to ensure that his/her Notification Platforms are operational for the purpose of receiving any notifications under this subclause. Prizes are provided for by CN and delivered by the Organiser. The Organiser's and CN's obligation to provide the prizes will be fully discharged upon distribution of the prizes to the relevant winners in accordance with the delivery details provided by the prize winner.
- 4.2 If such notification cannot be delivered or is not received by a prize winner for any reason, or if a prize winner fails to respond to the Organiser's notification within 30 calendar days of such notification, no further notifications will be given and the prize shall be deemed as forfeited. In such event, the Participant irrevocably waives all rights to claim the prize, and the Organiser may, in its sole absolute discretion, select another winning Participant in replacement.
- 4.3 All prizes are subject to the sponsoring merchant's applicable terms and conditions, non-refundable and non-transferable. The Organiser and CN reserve the right, at its sole discretion and without notice or liability, to change any prize(s) or to substitute any prize(s). No prize is exchangeable or redeemable for cash. If the Winner is required to pay any kind of taxes, including withholding tax, gift tax, duties, charges, levies in relation to the Prize as required under any applicable law, the same shall be solely and exclusively borne by the Winner.



4.4 The Organiser's decision in relation to the Prizes and Prize Winners is final and shall not be open to challenge or appeal. In this regard, no correspondence from the Participants will be entertained or responded to.

(B) GENERAL TERMS AND CONDITIONS

5. Personal Data

- 5.1 Each Participant agrees that the Organiser may collect, use and/or disclose each Participant's personal information to its officers, employees, appointed service providers, affiliated organisations and event partners, as may be required for the administration of the Programme and all matters arising thereunder.
- 5.2 Each Participant further agrees that the Organiser may use and disclose the Participant's personal data contained in his/her entry (including but not limited to his/her name, photograph or image, etc.) for the purposes of this Programme and for promotional, marketing and publicity purposes by the People's Association.

6. Responsibility for participation

- 6.1 Each participant shall be responsible for his/her use of any materials (including but not limited to works protected by copyright or other intellectual property rights) as part of his/her entries. The Organiser and CN shall not be responsible for any claims of infringement of intellectual property rights by third parties.
- 6.2 Save for any gross negligence or wilful misconduct on the part of the Organiser and CN, each Participant agrees to indemnify the Organiser and CN against any losses, damages, costs, expenses, claims or liabilities which the Organiser and CN may incur or suffer as a result of or in connection with the Participant's involvement in the Programme. For the avoidance of doubt, by participating, the Participant releases, discharges and indemnifies and keeps the Organizer, CN, each of their affiliated, associated and related companies and their representatives (collectively, the "Indemnified Parties") indemnified against any and all death, injury, harm, incapacity, trauma, theft or loss (including theft or loss of property), damage, claims and costs, tax liabilities, in any manner whatsoever, suffered and/or incurred by: (a) the Indemnified Parties as a result of Participant's breach of these terms and conditions; and/or (b) the Participant and/or any person related to the Participant as a result of participating or utilising the Prize and/or any act or omission pertaining thereto.
- 6.3 The Participant shall comply with all reasonable instructions and observe all relevant safety measures when submitting the entry. To the extent permitted by law, the Participant agrees not to hold the Organiser, CN, each of their affiliated organisations and event partners, officers, employees and agents liable for any loss, injury or damage suffered as a result of his/her participation in the Programme.
- 6.4 The Organiser and CN shall not be responsible for entries which are inaccessible, lost, misdirected, damaged or undelivered for any reason.

7. Usage of Participants' Entries



- 7.1 These Terms and Conditions does not affect the intellectual property ("**IP**") rights of the Participant or any other person under the applicable laws.
- 7.2 By submitting an entry, the Participant grants, or confirms that the original copyright owner grants (as the case may be), the Organiser and CN an unrestricted, royalty-free, world-wide, perpetual, irrevocable, non-exclusive licence to use, apply, reproduce, display (such as at a public exhibition), broadcast, modify, summarise, adapt, sub-license and communicate the entry and IP and at any time and for any purpose set out in these Terms and Conditions, including (but not limited to) communicating the entry and IP to the public or to any entity or for any other form of publicity, without any further approval from the Participant, or any payment or compensation to the Participant.
- 7.3 The Participant represents, warrants and undertakes that the entry does not infringe any IP rights or interests of any third party in the IP, and that all necessary consents for the use of any third-party IP in the entry has been obtained.
- 7.4 The Organiser and CN shall not be responsible for any claims of IP infringement by third parties as a result of the Participant's breach of these Terms and Conditions, and the Participant hereby agrees to indemnify the Organiser and CN against all such claims, demands and/or allegations.
- 7.5 The Organiser and CN shall not be required to bear any cost involved in the production of any entry.
- 7.6 For the avoidance of doubt, all rights, titles and interests on the Chingay Website (www.chingay.gov.sg) and its contents are owned by or licensed to the People's Association. No part of the content or material available on the Chingay Website may be reproduced, republished, transmitted, uploaded, posted, or otherwise distributed in any way without the prior written permission of the People's Association.
- 7.7 For the avoidance of doubt, the Participant agrees to use the downloadable template of CN available on the Chingay Website specifically and solely for the purposes of participating in the Programme.

8. General terms

- 8.1 The Participant agrees to comply with all prevailing laws as well as all reasonable instructions and requests made by the Organiser.
- 8.2 The Organiser may in its sole discretion and without liability exclude any entry from consideration in the lucky draws if:
 - it does not comply with these Terms and Conditions including posting/publishing an entry on an
 account other than the Participant's public post or account and or posting or publishing with an
 incorrect hashtag; or
 - the Participant has provided false or misleading information or otherwise breached any of these Terms and Conditions.
- 8.3 The Organiser reserves the right at its sole discretion to shorten and/or extend the deadline for submission and/or amend, modify, delete, replace or revise in the Organisers sole discretion, the terms and conditions without any notification or incurring any liability to any party whatsoever.



- 8.4 Participants agree to check the Chingay website from time to time for any updates or modifications to these Terms and Conditions and ensure that they familiarise themselves with these Terms and Conditions. Should any dispute arise in connection with the Programme, or with the interpretation or implementation of these Terms and Conditions, the Organiser's decision will be final and binding upon the Participant.
- 8.5 These Terms and Conditions shall be governed by and construed in accordance with the laws of Singapore.
